INVITATION FOR PROPOSALS TO OPENING GYM FACILITY AT KENDRIYA VIHAR SOCIETY

In the 9th Executive Committee (EC) meeting held on August 3, 2025, it was decided that the vacant space on the top floor of the Society Office should be put to productive use. To ensure optimal utilization and generate revenue, the Committee has decided to develop the space into a gym facility exclusively for the residents of Kendriya Vihar. Accordingly, KVAOWA now invites proposals from experienced gym operators or service providers for the establishment and management of a gym within the residential premises.

<u>Details of the Facility:</u>

- Total Area Allotted: Approximately 1500 Sq. Feet
- Location: Brahmaputra, Hall, CC-I, Kendriya Vihar Complex
- Minimum Expected Rent: ₹50,000/- per month (including reimbursement of expense e.g. Security expenses, repair and maintenance.
- Tenure of the agreement will be of four year and subject to renewal.
- Maximum Gym timing 05.00 AM to 10.00 PM.

Terms and conditions:

Interested gym operator (hereinafter known as licensee) is required to submit a detailed proposal that includes the information and agreement on following conditions:

- Only Kendriya Vihar residents will be allowed to use the gym. 1.
- Electricity and water charges to be borne entirely by the licensee. 2. Power back up charges will be as per the rate decided by the EC.
- Membership administration and related operations will be controlled 3. solely by KVAOWA.
- All membership fees will be collected and managed licensee. KVAOWA 4. will have no relation.
- Strictly no entry for non-residents or outsiders will be permitted. 5.
- Final terms and conditions will be determined after the selection of 6. the licensee and mutually agreed upon.

- All renovation, interior works, ACs and fixtures to be undertaken by 7. the selected licensee at their cost.

- Advance rent will be paid to KVAOWA first week every month and 17. interest free security of two months will be deposit to KVAOWA.
