### NOTICE

Sub: Allotment of Shops/Kiosks in Kendriya Vihar.

#### **TERMS AND CONDITIONS:**

(i) The applicant must be a member of the Kendriya Vihar Apartment Owners Welfare Association.

(ii) Members who have already been allotted a shop or kiosk and are in possession of the said shop/kiosk are not eligible for allotment of the shops/kiosks.

(iii) Successful applicants must note that the shops/kiosks, if allotted to him/her should not be sublet or let out by him/her to any third party. In case of any violation by the allottee the allotment will be terminated without assigning any reasons whatsoever and legal action shall be initiated against him/her at his/her own risk.

(iv) Members applying for the shops/kiosks should not be insolvent or have not been convicted of any offence involving moral turpitude or punished.

(v) Members of the present Executive Committee are not eligible for allotment of shops/kiosks.

(vi) Members indulging in Commercial Activities and having outstanding dues to KVAOWA are not eligible for allotment.

(vii) Two months' rent shall be deposited by the allottee towards security deposit.
