## NOTICE

Subject: Vehicular traffic management inside the Kendriya Vihar Society.

Our Society is going to install Boom Barrier with Automatic Number Plate Recognition (ANPR) cameras at gate No. 1 for entry and exit of registered vehicles. With the introduction of the ANPR system with Automatic Boom Barrier a few changes in the vehicular traffic management have been made. The residents are requested to go by the following guidelines in the vehicular movement inside the Society:

- 1. All residents are requested to register the authorized number(s) of their vehicle(s) with the Society Office. Those who have already registered/have Sticker need not submit the details again.
- 2. Parking of vehicles authorized for the residents inside the Society:
  - (a) Flat Owner with parking space Two four wheelers and 2 two wheelers, without any extra payment.
  - (b) Flat Owner without parking space One four wheeler and one two wheeler, without any payment and 2<sup>nd</sup> vehicle and 2<sup>nd</sup> two wheeler with charges of Rs. 1180/- and 590, respectively for 5 Years.
  - (c) Tenants One four wheeler and one Two wheeler- without charges. 2<sup>nd</sup> four wheeler vehicle with monthly charges of Rs. 1000/- including GST. Subject to satisfaction of the management/ EC about availability of adequate space in the entire Block. This arrangement is purely on an experimental basis.
- 3. As soon as the Boom Barrier with ANPR system is installed, entry of vehicle registered with the society will be allowed from Gate No. 1. Vehicles will be registered as per the norms given under sub paras (a). (b), and (c), above. The automatic barrier will not open for entry in the Society for the unregistered vehicles.
- 4. All unregistered vehicles will enter from Gate No. 3 with the approval of the Flat owner/host on the MyGate app.
- 5. For registration of the vehicles, there should no dues against the resident/individual. It is requested to pay all your dues such as AMS etc. in time.

6. With the introduction of ANPR and automatic Boom Barrier system from Gate No. 1 entry of registered vehicle will be allowed. Others including venders, commercial vehicles suppliers, sales men, couriers, swigy, zamato etc. will enter from Gate No. 3. Exit of all vehicles will be allowed from gate No. 1 only for the whole day where again Automatic Boom Barrier system with ANPR will be working along with MayGate app etc.
