CIRCULAR

Sub: Implementation of Govt. Policy on Elimination of single-use-plastic.

- 1. Being a Society of informed and enlightened citizens, Kendriya Vihar has always been taking a lead role in implementing all welfare and developmental schemes of the Government. True to its glorious tradition, Kendriya Vihar is once again coming forward with its wholehearted and relentless participation in the task of Nation building.
- 2. On this occasion I earnestly appeal to all the owners, residents, operators of commercial establishments and visitors of Kendriya Vihar to put a firm and irrevocable stop on single-use-plastic till 23rd January, 2023. Let us take a vow to carry our own cloth or jute bags for shopping. This, if scrupulously followed, will deprive the shopkeepers of any opportunity to provide bag most often, if not invariably, plastic for our purchase. Let us also resolve to bring to the notice of Law enforcement agencies, instances of violation of the law by any unscrupulous elements so that they can be dealt with appropriately. KVAOWA will facilitate all initiatives in this regard. Needless to add, as charity begins from home, let all of us resolve to refrain from littering prohibited items such as single-use-plastic, polythene bags, etc.
- 3. From 26th January, 2023 onwards, the Security of KVAOWA has instructions to be on vigil against storage, selling and/or use of single use plastic or any other prohibited item by any commercial operator ie Shops, Kiosks, etc in the campus. Any violations in this regard will be severely dealt with without any discrimination as the following:

Penalty ranging from Rs.1000/- to 25,000/- as decided by the KVAOWA Management depending upon the nature and seriousness of the violation.

- a) Reporting the violation to the law enforcement agencies.
- b) Termination of lease and eviction from the premises.
- c) Any other suitable action.
- 4. Co-operation of all is requested to make Kendriya Vihar a Model Society.
