## Appeal

**Subject: Appeal for Cooperation Safety and Security of Residents.**

Dear Residents,

This is an important appeal to all members of the society regarding recent incidents that have raised serious concerns about the safety and security of our community.

It has come to our notice that a few unpleasant and violent incidents have occurred within the society premises involving outsider students/boys. Upon review, it has been observed that certain residents are permitting entry of outsiders without adequate oversight. These individuals have been found roaming within the society premises on bikes and in cars without any specific purpose.

Additionally, it has been noted that residents conducting tuition classes are allowing outside students to enter the society. Post classes, some of these individuals have been seen loitering on rooftops, and engaging in rash driving within the premises, thereby posing a risk to residents, especially children and senior citizen. Alarmingly, there have been recent instances where such outsiders have allegedly been involved in altercations and attacks on children residing in the society. Such acts are extremely serious and may lead to criminal consequences.

In this regard, all residents are requested to:

- Don't permit outsiders to roam freely within the society.
- Any outside student/boys must remain within the resident's premises and exit the society immediately once the purpose of their visit is fulfilled.
- Residents must exercise strict responsibility while permitting entry to any such outsider.

In addition to the above measures, and in the interest of maintaining safety and discipline, the security team has been directed to strictly monitor and regulate the entry of visitors, and to prevent any unauthorized or unnecessary access. If any outsider found:

- Roaming without purpose,
- Engaging in rash driving,
- Involved in any suspicious or inappropriate activity, or
- Consuming alcohol/smoking in public areas/open areas in society

Will be subject to strict action, including legal and preventive measures.


