Annual Maintenance Subscription (AMS) for the financial year 2021-2022.

- 1. Executive Committee of KVAOWA in its 14th Meeting held on 14.03.2021 has fixed the Annual Maintenance Subscription (AMS) for the financial year 2021-22 (same as for year 2020-21) As in the past, 5% rebate will be given on the AMS, if paid before 30th April 2021 for full year.

- 3. AMS can also be paid in two equal instalments without any rebate.
  - a) First by 30th April, 2021.
  - b) Second by 31st October, 2021.
- 4. 18% simple penal interest shall be charged for late payments of instalment, i.e. after 30<sup>th</sup> April, 2021 and 31<sup>st</sup> October, 2021, respectively.
- 5. As you are aware, the last date for payment of AMS to avail 5% rebate was extended till 31st May, 2020 subject to approval by the AGM. The AGM held on 20/12/2020 has approved extension in view of the Coronavirus pandemic and the difficulties being faced by the members in payment of AMS as a onetime exception. Therefore, the excess payment made by the members/ owners last year will be adjusted in the AMS amount to be paid this year.
