#### Notes:

- 1. In case of programme is organized by the management for residents/ collegium/ EC members, no amount is payable, subject to approval of EC.
- There won't be any rebate in Electricity charges, AC charges, Cleaning/ washing charges, Repair & maintenance charges except for cases in (1) above.
- 3. Rental charges will be 75% for half day booking i.e. 8 am to 2 pm or 4 pm to 10 pm. in respect of halls/ kitchen. All other charges would be payable in full.
- 4. Rental charges will be 70% for spiritual meetings/ gatherings/ functions.
- 5. Rental charges will be 200% for non -members.
- Members can book halls for their own functions only i.e. related to their children/ grand-children/ parents/ grandparents/ family get-together/ friends get together, otherwise rental will be 150%.
- 7. Rental for one condolence meeting will be nil for two hours, only subsequently rental will be chargeable at 70%.
- 8. Only park in front of SAFAL i.e. Panchvati Vatika would be given.

- 9. Rs. 2,000/- will be taken as advance security for electricity bill for Morni hall and Rs. 1,000/- for others as against present security of Rs. 5,000/- and Rs. 1,000/-
- 10. Electricity will be charged for the reading (power consumed) at the rate prescribe by KV management for electricity with power backup from time to time.
- 11. Resident will be responsible for any damage to any property.
- 12. For cancellation 7 days in advance 50% rental charges paid will be forfeited and for less than 7 days, no amount is refundable, however if booking is done for that day than only 50% will be forfeited. Cancellation on same day, nothing is refundable other than security.
- 13. Above rates are applicable for booking done w.e.f. 1st June, 2025. For booking done upto 31st May, 2025, with full advance, earlier rates as per office order dated 12.06 2025 would apply.
