Subject:-

Regarding registration of Pet Dog.

It is brought to the notice of all residents that MCG is undertaking the registration of pet dogs under section 311 HMC ACT 1994 read with Bye Laws 3 of the Haryana Municipal Corporation (Registration and Proper Control of Dogs) Bye-Laws 2008.

As per the provisions contained in Sub-Clause No. 1, 3 & 5 of the Clause No. 03 of Haryana Municipal Corporation (Registration and Proper Control of Dogs) Bye Laws 2008 which reads as under:-

Registration of dogs:-

- (1) *The owner of every dog kept or brought within the area of Corporation shall, on or before the 1st day of April in each year or within seven days of its arrival in the Municipal area, get the dog registered at the office of the Corporation in the form "A". (copy of Form 'A' is attached herewith)*
- (3) *On registration, the owner shall be supplied by the Corporation with a metal token having name and address of owner engraved on it and the owner shall cause the dog to wear at all times the collar with the metal token supplied by the Corporation.*
- (5) *The registration and the metal token shall hold good for a period of twelve months reckoned from 1st April or from the date of Registration of dog to 31st March in each year.*

It has been observed that lots of people are keeping pet dogs but they have not registered the same with Municipal Corporation, Gurugram and did not obtain necessary license. It has been observed that pet dog owners are facing great difficulty for registration. To facilitate the owners of the pet dogs, MCG has engaged M/s Pet pulse (Dr. Amit Tripathi, Mob.7042623905) for registration of pet dogs at doorstep in MCG Area. The other activities to be carried out by this agency are summarized as under:-

- a. Tagging the animal by injecting tag subcutaneously behind the neck (between the shoulder blades).
- b. Issuing a metal token and;
- c. Issuing a pet license card;

- d. Maintaining an online database for at least three years from commencement of the project.
- e. Awareness regarding ABC Rules 2023, Prevention and Cruelty of Animals Act 1969, Section 311 of HMC Act 1994 and Licensing and Regulation of Pet dogs Bye-Laws and various amendments or direction issued from time to time, vaccination, behavioural, poo bag, keeping on leash while roaming outside with the help of volunteers, NGO, RWA, etc.

All RWAs are requested to inform all the members of RWA/pet owners and to extend cooperation in this regard. You are further requested to contact M/s Pet pulse (Dr. Amit Tripathi, Mob.7042623905) for organizing camps in your area.

Your cooperation will be highly appreciated.
