### OFFICE ORDER

This is further to Office Orders No. KVAOWA/GGN/2023/52/4276 dated 24th August, 2023, and No. KVAOWA/GGN/2025/52/184 Dated: 17th May, 2025, the following charges are hereby prescribed for the services mentioned herein, as approved in the Executive Committee (EC) meeting held on 12<sup>th</sup> April, 2026.

As decided by the Executive Committee, a separate schedule of charges shall be issued specifically for community religious programs organized jointly by the residents of the society. Accordingly, charges applicable are as follows:

**“Community cooperative Religious Program”**


The aforesaid charges shall be applicable for bookings of up to a maximum of two days only.

In the event that a Community Religious Program is booked for more than two days, the rental shall be calculated as follows:

- a) For the AC Hall, 50% of the applicable rental shall be charged for all days booked for the program; however, charges towards AC usage, cleaning, and repair & maintenance shall be levied only for two days.
- b) For the Non-AC Hall, 30% of the applicable rental shall be charged for all days booked for the program; however, charges towards cleaning and repair & maintenance shall be levied only for two days.

**Charges Applicable for Individual Personal Programs**

1. Rental charges will be 200% for non-members.
2. Only park in front of SAFAL i.e. Panchvati Vatika would be given.
3. ₹2,000/- will be taken as advance electricity security for Morni Hall and ₹1,000/- for other halls (adjustable).
4. The resident will be responsible for any damage to property.
5. For condolence meeting AC hall will be given free for 6 Hrs and no electricity charges will be charged.
6. For cancellation 7 days in advance 50% rental charges paid will be forfeited and for less than 7 days, no amount is refundable, however if booking is done for that day than only 50% will be forfeited. Cancellation on same day, nothing is refundable other than security.
7. Rental for events up to 2 hours will be charged half day rental +other charges in full.
8. Electricity will be charged as per actual consumption as approved by the KVAOWA.
9. The above rates for “Community cooperative Religious Program” are applicable for bookings done w.e.f. 12.04.2026. (Date of EC Approval)
