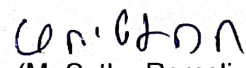

ELECTION NOTIFICATION

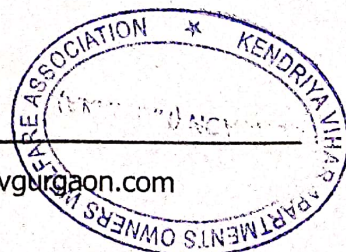

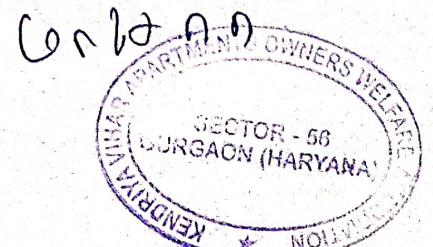
